- Training and leading Family Camp Counselors to assist with carrying out all Family Camp programming.
- Interacting enthusiastically with the Director's family during meals, activities, and free • time
- Encouraging and leading Family Camp Counselors to teach campers about Jesus Christ and ٠ the biblical themes and curriculum presented.
- Ensuring that all programming areas are tidy, supplies are well stocked, and equipment is in • good working order.
- Ensuring that all children and youth are supervised and cared for well during parent • programming.
- Assisting with the serving and clean-up of camper meals. •
- Assisting with weekly camp cleanup and preparation for the next group of arrivals. •
- Coordinating with and supporting other camp departments for the overall benefit and experience of camp.

Spiritual Encouragement – You'll be responsible for maintaining a program and environment that nurtures spiritual growth for campers and staff alike. Good examples of this are:

- Prioritizing your personal relationship with God by praying often, living by faith, and • spending meaningful time in the Word of God.
- Leading by example through words and actions, pursuing excellence and godliness in all

- Excellent communication skills (verbally interacts with campers, parents and staff, and writes evaluations and letters to campers)
- Respect for authority

- O Ability to interact well with kids, peers, and parents/adult family members
- Ability to participate in all camp activities
