WHAT YOU'LL GET TO DO

The Healthcare Administrative Assistant reports to the Healthcare Director and assists in the management of the Health Center. This position is not responsible for anything that requires formal medical training or licensing. This role is critical to the ministry of Sky Ranch and contributes directly to our mission of leading youth and families to know and follow Christ.

A DAY IN THE LIFE

(The legal term is "essential functions." That just doesn't sound as fun!)

The Healthcare Administrative Assistant ensures the Health Center is ready to serve campers and staff and respond to emergencies daily. No two days will ever be the same at camp, and there's no way we could possibly list everything you'll experience! Here's just a glimpse of the most important responsibilities you'll have:

Daily Operations –You'll ensure that the health center functions according to the daily program schedule and in accordance with Sky Ranch policies and procedures.Here's what that looks like:

- Helping to set up Health Center offices, preparing copies, forms, and reports
- Assisting with med calls and treating campers and staff for minor injuries and illnesses under the direction of the weekly Healthcare Professional
- Transporting ill or injured campers and staff to the clinic or emergency room, when needed
- Ensure the Healthcare Team is properly entering data and maintaining data logs, coordinating and communicating with summer camp staff, daily.
- Responding with a camp nurse to Code Med and Code EMS calls, or any other time, as needed
- Managing work-related injuries when the Healthcare Director is not available.
- Managing the Health Center when the Healthcare Director is not available.
- Managing the Healthcare Team's schedule.
- Conducting Healthcare Team's one-on-one meetings weekly.
- Assisting with the management of medication administration on opening and closing days.
- Managing supplies for the Health Center and restocking them as needed.
- Being available after hours when on call.

Spiritual Encouragement – You'll be responsible for assisting counselors in creating an atmosphere and delivering programs that nurture spiritual growth for campers and staff. Examples of this are:

- Pursuing your own relationship with God.
- Demonstrating selflessness, being willing to serve where needed, wholeheartedly, without hesitation.
- Exhibiting a Christ-like attitude and genuine concern for campers and counselors, displaying the qualities taught in Bible studies and devotionals.
- Leading or participating in daily devotionals each morning with Health Center staff.
- Attending weekly Community Group time with Healthcare Team members.

Customer Service –You'll ensure that our campers and camper parents experience the "WOW" factor and are served in a way that reflects our desire to serve them as well as our appreciation for them and meets or even exceeds their needs and expectations.

- •Treating ALL our guests, both campers and their family members, with gentleness, kindness, fairness, respect, and eagerly seeking to meet their needs.
- ·Bringing to the attention of the Camp Director ANY situation where we fail to serve or please a guest.

Other important responsibilities are to maintain compliance with all employee policies and procedures established for Sky Ranch, maintain compliance with all state and federal laws and regulatory requirements, and perform other tasks requested of you with a fantastic, spirit-to-serve attitude.

WHAT YOU'LL NEED

EVERYONE who works at Sky Ranch needs to have a current MinistrySafe / Child Advocacy Certification. Don't worry, we'll provide that for you if you don't have it already!

You'll also need CPR, First Aid, and AED Certification.We'll provide this for you, too!

You'll also need to exhibit the following character traits, knowledge, and skills. You'll have to show up with these – we can't get them for you! If you can check these boxes, you're good to go:

- Committed follower of Jesus Christ, and willing to sign the Sky Ranch Doctrinal Statement
- Committed to providing excellent customer care and willing to contribute to the mission of leading youth and families to know and follow Christ
- Ability and desire to keep kids safe, as well as care for them physically, emotionally, and spiritually
- Ability to abide by rules and regulations
- O Willingness to abide by the Sky Ranch cell phone policy.
- Excellent communication skills (verbally interacts with campers, parents and staff, and writes evaluations and letters to campers)
- Respect for authority
- **O** Flexibility and adaptability when things change or go in a way that is not expected

- O Ability to interact well with kids, peers, and parents/adult family members
